Joy King started the meeting at 7:05 p.m.

Joy mentioned that spots were still open for volunteers for the Gulf Coast Classic contest. There is no entry fee for people who volunteer.

Officer Reports

Treasurer: Joy King

(See the attached financial report.) She said we received more membership money and \$600 more for the Sam McBurnett account. His family would like to sponsor a yearly \$1,000 scholarship in his name for 5 years. Right now there is about \$5,600 in the account.

We are still waiting for the final amount raised by us for the US Bands competition. There is no check yet. Joy thinks it is supposed to be about \$13K but with expenses paid of \$6,000 already.

We got another \$500 on the mattress sale. They had accidentally switched checks between us and FFA and our portion was \$500 more.

Joy called attention to a couple of big expenses this month. We paid for competitions and big rig expenses. So far we have paid about \$7,000 for tractor expenses. That includes rental for Larry K.'s tractor and towing, diagnostic, and repair expenses on our rig.

Jacob Berry asked about big rig and said he thought Larry Rupp was trying to get work order from shop. Joy pulled up the receipt from the first diagnostic and repair and said it was about \$3,000, which included \$700 for the diagnostic and \$2,300 for the repair. (Larry Rupp joined the meeting by phone and said they sent out the other truck computer module to Tampa for testing.)
